## **Recipient categories**

## Rights of the interested party

- the deletion of personal data concerning you (upon the occurrence of one of the conditions set out in Article 17(1) of the Regulation and in accordance with the exceptions set out in paragraph 3 of the same Article)
- the restriction of the processing of your personal data (in the event of the occurrence of one of the hypotheses indicated in Article 18, paragraph 1 of the Regulation), the transformation into anonymous form or the blocking of data processed in breach of the law, including data whose storage is not necessary in relation to the purposes for which the data were collected or subsequently processed.

As a data subject, you also have the right to object in whole or in part

- on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of collection
